2021 Speaker Agreement

By submitting this proposal, I acknowledge the following as (or on behalf of) a potential presenter at Identiverse® 2021:

- I agree that my submission may be evaluated and selected for use in any of the following: a presentation as part of the in-person 2021 Identiverse Conference (the “Conference”), a live or pre-recorded virtual presentation as part of the Identiverse 2021 conference; a webinar, a blog, or some other form of content used for Identiverse.

- My presentation—both visually and orally—will not include product pitches, confidential or proprietary information or vendor-biased content.
- I will submit my presentation for review and approval on time (no later than one month before the conference start date; final dates to be confirmed and communicated to you if your proposal is accepted).
- I understand and agree that my presentation title, abstract, bio, headshot and social media details (if provided) will be used on the Identiverse website and in other Identiverse promotional or agenda material, and I hereby grant Identiverse the limited non-exclusive rights and license to use such items.
- I understand and agree that my email address will be used by the Identiverse organizers to communicate with me about the Conference or other logistical items pertaining to Identiverse.
- I understand and agree that my presentation at the Conference or for other Identiverse uses may be filmed and that this film and the presentation may be made generally available as part of the post-Conference material, and I hereby consent to such filming and any post-Conference use.
- If chosen to present at the Conference, I understand that the format (in-person or virtual) of my presentation, and the day and time of my recording (if applicable) and speaking spot will be assigned by the Identiverse Content Committee to fit into the parameters of the overall Conference agenda. Scheduling requests can be made but are not guaranteed.
